I am directed to state that it has been decided to hold a Limited Departmental Competitive Examination for promotion from JTO (Arch.) to the cadre AE (Arch.) under 33% quota for the **vacancy years 2009-2010 & 2010-2011** for vacancies in general category as per the provisions of the Recruitment Rules of AE (Arch.) issued vide letter No. 24-20/2001-Pers-II dated 28.02.2002 as amended from time to time.


2. (a) The examination will be conducted as per the syllabus and Scheme of examination circulated vide letter No. 106-20/2007-Arch dated 07.1.2008 issued by Arch. Wing, BSNL CO. The detailed time table of the examination is given as below:

(b) Officials who are eligible in accordance with the eligibility conditions as referred above and who desire to appear in the examination should submit application on-line without fail, the facility for which will be available on [www.internalexam.bsnl.co.in](http://www.internalexam.bsnl.co.in). The proforma of the application for on-line registration will be similar to Annexure 'A'. The instructions to fill up the application are given at Annexure 'B'. Applicants are requested to adhere to the instructions and register/submit their application after going through the instructions thoroughly. After registering online, the applicant must take a print out and submit the same to the controlling officer after completing all formalities as given in the instructions (Annexure 'B') for onward submission to DGM(A) of the respective Recruiting Circle for record purpose.


(c) The evaluation of Paper-I will be OMR (Optical Mark Reader) based and as such each question will have multiple choices for answer. Only one answer which is the most appropriate has to be selected by the candidate. who should darken the relevant bubble accordingly. **In case of wrong answer, 25% marks of that question will be deducted** and as such the candidates are advised not to resort to arbitrary selection of answer. In case the candidate darkens more than one bubble, it will be treated as wrong answer and 25% marks of that question will be deducted and as such, the candidates should darken only the relevant bubble.

3. The examination shall be conducted strictly in accordance with the rules laid down in Appendix No. 37 of P&T Manual Vol. IV (Fifth Edition) and instructions issued in this regard from time to time. The examination will be conducted by the Heads of Territorial Circles including NTR, New Delhi, Chennai Telephone Distt. and Kolkata Telephone Distt. and will be held at such Centres as may be fixed by them on the said date.

**INSTRUCTIONS FOR FILLING UP ONLINE APPLICATION FORM**

[PLEASE READ ALL INSTRUCTIONS CAREFULLY BEFORE PROCEEDING FOR ONLINE REGISTRATION FOR LDCE]

1. The online registration of application is mandatory. If any eligible employee does not register his application online, he will not be allowed to appear in the examination.
2. The on-line registration is open only for **22 days i.e. from 14<sup>th</sup> February, 2011 to 7<sup>th</sup> March, 2011**. No request for extension of time for on-line registration will be considered.
3. The applicant should fill up the information correctly and carefully during on-line registration as there will be only one chance to make online registration.
4. The applicant is required to register online by giving self generated user ID and the Password. The applicant is requested to remember his user ID and password for future use. The system will ask the applicant to input his HRMS No. into the system. The data pertaining to fields at Sl.No.3, 5, 6 & 13 will be picked up by the system from the HRMS data and rest of the fields are required to be filled up by the candidate correctly.
5. After registering online, the applicant must take a print out and submit the same to the controlling officer for onward submission to DGM(A) of the respective Recruiting Circle for record purpose.
