Any request for declination of promotion will not be entertained by Administration due to administrative exigencies

On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide No.400-106/2007-pers I dated 14.07.2009.

The officers in case is officiating/looking on in the higher grade locally, the arrangement shall stand terminated before implementation of this order.

The seniority in the grade of CAO(Regular)will be communicated subsequently.
