Sub: Officiating promotion in the cadre of Junior Accounts Officers- reg.

The following officials mentioned in the enclosed Annexure, who have been declared qualified in the JAO Part-II Internal Competitive Examination held on 4.01.2010 to 06.01.2010 against 40% quota, the Review Results of SC/ST Candidates which were declared vide CGM TN Circle Ir.No.RET/52-1/2009 dated 31.03.2010, are hereby ordered to officiate as Junior Accounts Officers, in the SSAs noted against each in the existing vacancy.

On promotion the pay of the officials are fixed in the pre revised IDA scale of pay Rs.9850-250-14600 with immediate effect or from the date of assumption of charge whichever is later.

The above promotions are purely temporary and on local officiating basis for a period not exceeding 89 days from the date of assumption of charge or up to the date of relief for JAO Induction Training or till regular incumbents are posted by BSNL HQs whichever is earlier.

The promotion will not confer any right to the officers to continue in the same post/Station/Grade or have any claim over Seniority in the grade of JAO.

Before implementing this order the Head of SSAs should ensure that no disciplinary/vigilance case is pending against the officials. In case any disciplinary/vigilance case is pending against the officials he/she should not be promoted and the matter should be reported to this office.

If the officials are on leave/training, they shall be promoted with effect from the date of joining from such leave/training.
