The arrangements made under this order will neither bestow on the officer any right to claim for their regular appointment in the grade of AO nor will the service rendered by them be counted for the purpose of seniority in the grade or for promotion to the higher grade.

The above officiating arrangement is subject to the condition that there is no vigilance/disciplinary case is pending/contemplated against the officer or some punishment like stoppage of increment is current.

In the case of officers posted to officiate out of the SSA in which they are presently working as AAO/JAOs, they may first be transferred to the SSA in the substantive grade and be posted directly to officiate as Accounts Officer and TA/TP may be regulated as per guidelines issued by BSNL vide letter no. 19-27/2002-L&A (Part) dated 15-04-2004.

The pay of the officers will be fixed as per instructions issued vide OM No.1-50/2008-PAT (BSNL)/ dated 05.03.2009 read with Ir.no.400/61/2004-PERS-I dated 18.01.2007.

In view of the above officiating order, the officiating order issued vide this office Memo No.TSA (F)/12-15/2010/65 dated 22.10.2011 is terminated with immediate effect. No looking after arrangement in the grade of AO shall be made at the SSA level.
