The Executives would not have any claim for their seniority/regular service in DGMs grade of Telecom Finance based on this ad-hoc promotion. Their seniority will continue to be determined with reference to their basic seniority in the substantive grade of CAOs/AGMs of Telecom Finance Service(STS level)
